RULES REGULATIONS AND MANAGEMENT OF TRUST.

**THIS TRUST AMEND AGAINST DEED NO.08, TOKEN NO.1255/2015
DATED- 13/02/2015**

- i. The objective and purpose of the Trust shall be as mentioned above in point 3 (i).
- ii. Definition in these rules:-
- a) Trust means **SRI RAM EDUCATIONAL & WELFARE TRUST.**
- b) Board of Trustee/Government body means the board which under the rules is constituted to be the board of Trustees/Government body of the Trust.
- c) Managing Trustee means the founder Settler Chairman of the trust.
- d) Year means the financial year beginning from, April / to March (but first year shall be deemed to have commenced from the date of registration ended on 31 March).
- e) Act means the Indian Trust act 1882.
Board of trustee means office bearer of the trust for administration, management of affairs & properties of the Trust.
- f) Founder member means the settler on one part the trustees on other part.

SPOWER OF TRUSTEES :-

The Trustees will also have the following powers :

- i) To apply the whole or part of the income or accumulation thereof or whole or part of the corpus or the trust properties for one or more of the objectives of the Trust as the Trustees may from time to time determine.
- ii) To amalgamate the Trust with any other Trust or society for wholly charitable purpose.
- iii) To convert and get in the Trust properties and/or to vary the investments for the time being.
- iv) To invest and keep invested the Trust properties in the purchase of immovable properties or in other assets specified in section 11(5) of the Income Tax Act, 1961 and to alter vary and transpose such investment from time to time as the Trustees shall, in their absolute discretion, think fit, The Trustees shall have powers to acquire land, property and sell the assets etc. in the interest and benefit of the trust.

v) To invest dispose off, transfer and otherwise deal with the subject matter as the Trustees deem fit and proper to do carrying out the object of the Trust.

vi) To open account with any Bank or post office for the purpose of keeping the money of Trust, to operate such accounts including overdraft accounts and to give instruction to the Bank or post office and to provide for opening and operation of such accounts jointly by secretary and treasurer of the Trust.

vii) To make, vary, alter or modify schemes, rules and regulations for carrying out the object of the Trust and for the management of the affairs thereof and of running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the trust.

viii) To set apart the whole or part of the income or the corpus or part thereof for any of the objects of the Trust.

ix) It shall be lawful for the Trustees to settle and determine all matter of interpretations of these presents as well as all matters of difficulties, or doubts or disputes and all questions arising in the course of or incidental to and the administration, management and execution of the Trust and power of these presents any such settlement or determination shall be valid, binding and conclusive and shall not be objected to or

x) To settle compromise or compound, out of Court, all suits, actions and other proceedings and to settle all differences and demands and to refer any or all such suits, actions or other proceedings, differences or demands to arbitration and to adjust and settle all accounts relating to the Trust fund and execute release and to all things relating thereto as fully as if they were absolutely entitled to the Trust Fund for the benefit of the Trust.

xi) The Trustees shall be at the liberty to allow and permit any other Trust, institution or charity in any local area or areas whose objects are the same or similar to those of these presents to be amalgamated with the Trusts, created by these present to the extent and effect that such other Trust, Institution or charity shall be deemed to be a part and parcel of the Trust of these presents, provided, that no conditions are accepted which involve a change in the name of the Trust or the inconsistent with or repugnant to the objects thereof.

xv) To do all such lawful acts and things are identical and conducive to the attainment of the objects of the Trust.

DUTIES OF THE TRUSTEES :-

- i) The Trustees shall be chargeable only for such money, stocks, shares and funds that shall actually come into their hands, and shall not be answerable or accountable for neglect, default acts of omission or commission of the other Trustees nor of any Bankers or other persons with whom the Trust properties or any securities may have been deposited or handed over unless caused by their willful neglect or default.
- ii) All the Trustees shall be bound to maintain and defend all such suits, and (subject to provision of this deed) to take such other steps as may be reasonably requisite for the preservation of the Trust property and the assertion or protection of the title.
- iii) The Trustees shall be bound to deal with the Trust property as carefully as a man of ordinary prudence to deal with such property as if it were their own. And in the absence of a contract to the contrary, a trustee so dealing shall not be responsible for the loss, destruction or deterioration of the Trust property.
- iv) If the Trustee shall commit or threatens to commit any act which shall be destructive or permanently injurious to the Trust property, the remaining Trustees shall be bound to take measures to prevent such act.
- v) The Trustees shall be bound to keep clean and accurate accounts of the Trust property at all reasonable times.



RIGHTS OF THE TRUSTEES :-

- i) The Trustees will be entitled to reimburse themselves of all expenses actually incurred by them in connection with duties or activities performed by them in attainment of objectives of the trust.
- ii) The Trustees may from time to time associate with the activities of trust any person or persons of public eminence as patron or patron in -chief any may appoint or make provision for engagement of committee or managing committee or Board of Directors consisting wholly of the trustees or partially of Trustees and partially of others as the Trustees may decide for the purpose of management and administration of any projects or schemes institutions academic institutions established or undertaken by the Trust in consonance with the object of the Trust. Appointment of the members of committee managing committee or Board of directors shall be by the Board of Trustees. The secretary of the trust shall be the ex-officio secretary and the principal executive and head of such committee(s) managing committee(s) or the Board of Directors constituted by the Board of Trustees. Such committee, managing committee or Board of Directors shall work under the direct control and supervision of the Board of Trustees.
- iii) The Trustees may from time to time frame schemes, rules, regulations, laws and bye-laws for regulating the affairs of the projects undertaken and the institution established by the Trust for furtherance of the various objects, such rules as framed by the Board of Trustees for the conduct of affairs of the projects and institution shall be binding and no deviation shall be permissible in any of the rules by any authority whatsoever connected with the said projects or institution without the prior approval of the Board of Trustees.
- iv) a) The Trust may have an advisory committee of national level to advise the trustees on the activities of the Trust and to suggest how to make them better serve its aim and objects. The strength of the Advisory committee shall not exceed 9 (nine) at a given time. The members of the advisory committee shall serve the Trust in honorary capacity but they may be reimbursed such expenses as any be incurred by them for attending the meeting of the advisory committee, if so considered by the Trustees.
- v) The receipt granted by a persons authorized by the Trustees by resolution of the Board of Trustees for any moneys paid or any property transferred of delivered to

the Trustees in execution of any of the Trust or powers thereof or for the purchase of any property authorized to be sold shall effectually in charge any person or persons so paying transferring or delivering.

vi) To appoint attorney or agents and delegate to such attorneys or agents all or any of the powers vested in them these presents from time to time and remove such Attorneys or agents and to appoints other or others in their place.

Rules of the Trust

The Trustees may from time to time frame rules for the conduct of the affairs of the Trust and regulating the meeting of the Trust in the absence of the regulations. The Trustees for the time being of these presents shall be chargeable for only such money stocks, funds, deposits and securities as they shall actually receive notwithstanding their signing of any receipt, neglects, defaults and not for those of each other or of any Banker, pioneer or any other person with whom or into whose hands any Trust moneys or securities may be deposited or come in accordance with these presents nor for the deterioration or loss of any stock, funds, deposits, or securities nor for any other loss shall happen through their own willful default.

i) All matters will be decided by the majority.

Minimum three trustees i.e. Chairman, Secretary and Treasurer shall form a quorum for the purpose of taking decisions with regard to any function or any activity of the trust.

ii) Resolution passed by circulation (without any meeting of the Trustees and evidence thereof in writing) under the hands of President, Secretary and Treasurer shall be as valid and effective as resolution duly passed at the meeting of the Trustees.

iii). The existing Trustees may appoint one or more Trustees at their discretion from to time, but in any cases, the total number of the Trustees to be appointed shall not exceed eleven, the Trust property shall be vested in the New Trustees jointly with the continuing or surviving Trustees Powers and subject to this Trust.

MEETING

- i) The meeting of the Board of Trustees shall be held at least four times in a year but more number of meetings may be called by the secretary if necessary. The meeting may be held at any place within the India at the discretion of the secretary of the Board of Trustees.
- ii). A minute Book shall be kept by the secretary wherein entry of all the proceeding of the meeting of the Board of Trustees shall be made which shall be signed by the secretary of the meeting either at the conclusion thereof or at the next meeting.
- iii) The Trustees may if consider necessary in the interest of trust to add or to delete or amend declaration of Trust and on such addition, deletion or variation of terms contained in the deed by a resolution of Trustees unanimously the terms of this declaration shall be deemed to contain the terms, with such amendments deletion or variation.
